We might obtain information about you from other sources such as LinkedIn, corporate websites, credit reference agencies, professional advisors, business cards and personal recommendations.

# HOW DO WE USE YOUR PERSONAL INFORMATION

We may use your information in the following ways:

- To carry out our obligations arising from any contracts we intend to enter with you
- To contact you in relation to services and goods we offer
- To provide our recruitment services to you

- To engage the services of a third party (where instructed to do so)
- To comply with legal and regulatory obligations
- To send you updates, or information in relation to products and services that may be of interest to you

#### **YOUR RIGHTS**
